For the three-month period ended 31 March 2023, the Company's revenues were 452.80 MB. In O1/2023. Company's revenues consist of revenue from sales of 67.57 MB, revenue from services of 379.64 MB and other income of 5.59 MB, representing 14.92%. 83.85% and 1.23% of total revenue, respectively. The revenue from services derive from 3 main business, which are Data Center & IT Infrastructure, followed by, Maintenance and Service Business, and Telecommunications and Transportation Infrastructure, respectively. The revenue 's proportion of each type of business to total revenue from services accounted for 71.92%, 14.37% and 13.71%, respectively

Risk Management Policy

- 1. Risk of relying on major customers The company is a subcontractor receive work from main contractors, especially W&W, a company in the TRUE group, which has a relationship with the Company as partners and allies in doing business for a long time. Therefore, there is a risk of relying on such large customers and may have a significant impact on revenue, operating performance including the company's financial position. The company has policies and guidelines to reduce dependence on major customers both in the short and long terms with the goal of expanding the customer base and operating as a one-stop service and reduce dependence on few customers.
- 2. Risk from accrued revenue The company recognizes revenue from projects according to the percentage of completion, which is usually divided into several periods. It may cause the risk on liquidity and the risk of not being able to collect money from customers who have already received services. The company therefore has serveral policies such as meeting with customers to follow up the issues, reporting the project progress, billing and collecting status of customers to ensure that the company can collect the money according to the contract and solve any problems that may arise immediately.


Revenue Structure
